

**BOTA BOX “BRING ON THE ADVENTURE SUMMER” SWEEPSTAKES - OFFICIAL RULES**  
**NO PURCHASE NECESSARY TO ENTER, PLAY, WIN OR REDEEM PRIZE(S). A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. NO ALCOHOLIC BEVERAGES ARE INCLUDED IN ANY PRIZE(S).** This Sweepstakes is sponsored by Bota Box Vineyards, 12001 S. Highway 99, Manteca, CA 95336 (the "Sponsor").

- 1. ELIGIBILITY.** Sweepstakes participation is open only to eligible legal residents of the 50 United States and the District of Columbia (excluding Utah and where prohibited or restricted by law), who are 21 years of age or older at the time of entry. The Bota Box “Bring on the Adventure Summer” Sweepstakes ("Sweepstakes") begins 12:00 AM Pacific Time ("PT") on June 2, 2019 and ends 11:59PM PT on July 26, 2019 ("Sweepstakes Period"). All entries become the property of Sponsor and will not be acknowledged or returned.
